

## A brief history of the TG

The Thematic Group 10 on Digital Sociology was approved by ISA in May 2020 and had the first Business Meeting in Porto Alegre 2021, but the story is a bit longer. To keep the roots of the TG for the memories, hereby we will summarize the process of creation followed.

A seminal meeting was held at Toronto 2018 conference by a small group of sociologists interested in “the digital” the discuss the lack of space devoted to this topic in ISA conferences and how that was making it difficult to create a roadmap to track digitally related contents in the conferences. In ISA World Conference 2014, 16 Sessions in 12 Research Committees were devoted to digitally related contents, meaning around 64-80 papers. These numbers increased in ISA World Conference 2018, where 27 sessions in 19 Research Committees were thematically linked to digital contents, meaning around 108-135 papers presented. Our proposal aimed to accommodate some of these presentations and foster relevant discussions to help the field grow. After an initial rejection, due to the internal complexity

of ISA concerning the increase of groups and committees and the dispersion of knowledge, the decision was reconsidered and the TG10 Digital Sociology was finally accepted as a new member of the sociological family, allowing us to hold our first sessions in the next World Conference in Melbourne.

### Call for Volume 2: Mapping the Field of Digital Sociology


The Publications Committee of the Digital Sociology Thematic Group of the ISA is delighted to announce a call for research mapping out the field of Digital Sociology

## News from our members

A project that may be of interest to the thematic group is "[Artificial Intelligence and Inclusion in Latin America](#)" developed by the NGO Derechos Digitales thanks to the support of IDRC, which seeks to analyze different initiatives related to automated decision systems and AI in four Latin American countries (Chile, Brazil, Uruguay, and Colombia), identifying areas for improvement in light of existing international principles and good practices. The four case study reports, in Spanish for now, are openly available on the website, as well as a document reflecting on the implementation of automated decision-making systems at the regional level. A second publication that I would like to share is an article we published with Martín Tironi in the journal *Science as Culture*: "Experimenting with the Social Life of Homes: Sensor Governmentality and Its Frictions". This is a sociological study about the National Monitoring Network (or ReNaM), a state initiative that installed 300 environmental sensors in homes from five cities of Chile to know in real-time the performance of houses in variables such as temperature, humidity or CO2. The data is expected to improve the design of sustainable building policies and regulations. In our article, we critically interrogate the forms of knowledge and power that are activated by sensor-based state initiatives such as ReNaM. 

### By Richard Miskolci:

New Book (In Portuguese): "Batalhas Morais: política identitária na esfera pública técnico-midiaticizada" available for purchase on Amazon and other online book stores.

It resulted in my thesis for a Full Professorship at the Federal University of São Paulo (UNIFESP). The book analyses how the public sphere has changed since the hegemony of commercial social network platforms in the decade of 2010. Based primarily on the Brazilian case, it shows how the techno-mediatic public sphere arose during the 2013 protests paving the way for the extreme-right successful campaign against human rights and winning the 2018 elections.



In a social-shaping of technology perspective, I avoid any technological determinism in the book adopting a clear sociological analysis based on the association of the reconstitution of social and historical context, the role of the new mediatic ecosystem with the cultural practices spread through them.

The book shows how the new techno-mediatic public sphere has at least three main features:

1. It is shaped by the commercial interests of the online social network platforms;
2. The techno characteristics of the interactions in these platforms and this new public sphere in particular, like their algorithms and unification of profiles;
3. The mediatic rules that shape the interactions creating entrepreneurs of all kinds, individual, segmented and collective.

Based on the Brazilian case, the book gives special attention to the fact that the new techno-mediatic public sphere created the best conditions for the extreme-right to reorganize itself as moral entrepreneurs while creating competition and divisions inside the advocates of social justice now transformed into entrepreneurs of themselves (and particular causes).
